ARTICLE VII FIDUCIARY POWERS

Fiduciary Powers.

A. Whenever it is provided herein that any person shall benefit if such person shall survive me, that person shall be deemed not to have survived me if he or she shall die within fourteen (14) days after my death.

B. Where appropriate to the context, pronouns or other terms expressed in one number and gender shall be deemed to include the other number and gender.
