

LAST WILL AND TESTAMENT

of

TATIANA TRUHEART

I, TATIANA TRUHEART, an adult resident citizen of County, LOUDOUN COUNTY, VIRGINIA, being of sound and disposing mind, memory and understanding, do hereby make, publish, and declare this my Last Will and Testament, and I do hereby revoke any and all prior wills and codicils heretofore made by me.

I am married to my HUSBAND, DIEGO ALEXANDER TRUHEART. I have THREE children at the time of making this Will. They are DAUGHTER, VALENTINA TATIANA TRUHEART, AGE FOUR, SON, ALEXANDER DIEGO TRUHEART, AGE SEVEN, AND SON, DONOVAN FREDERICO TRUEHEART, AGE TEN.

ARTICLE I

PAYMENT OF FINAL EXPENSES, TAXES AN DEBTS

I hereby direct my Executor to pay all expenses of my last illness, funeral, burial, and administration of my estate and all of my just debts which may be probated, registered, and allowed against my estate, and the administration of my estate be paid out of my residuary estate and without the necessity of prior Court approval, as soon as may conveniently be done.

ARTICLE II

SPECIFIC BEQUEST

I bequest to my children, DAUGHTER, VALENTINA TATIAN TRUHEART, SON, ALEXANDER DIEGO TRUHEART, AND SON, DONOVAN FREDERICO TRUEHEART \$10,000.00 each, if they survive me. I hereby designate my HUSBAND, DIEGO ALEXANDER TRUHEART to be the custodian under the Virginia Uniform Transfers to Minors Act (25). If my husband predeceases me, my executor will be designated their custodian.

ARTICLE III
DISTRIBUTION OF TANGIBLE PERSONAL PROPERTY

If I leave a memorandum or list, signed by me, with this Last Will and Testament directing the disposition of certain items of my tangible personal property. Any such memorandum or list Last Will and Testament incorporated in this Will by this reference in accordance with Section 64.2-400 of the Code of Virginia. If such a memorandum or list is found, I ask my Executor to abide by it. If such a memorandum or list is not found within forty-five (45) days of my Executor's qualification on my estate, it should be presumed that no such list exists.

To the extent items of my tangible personal property are not otherwise specifically and effectively bequeathed herein or in such memorandum or list made by me, my Executor shall distribute in kind items of my tangible personal property to my HUSBAND, DIEGO ALEXANDER TRUHEART, if he survives me, or if HUSBAND, DIEGO ALEXANDER TRUHEART does not survive me, my children, DAUGHTER, VALENTINA TATIAN TRUHEART, SON, ALEXANDER DIEGO TRUHEART, AND SON, DONOVAN FREDERICO in shares as equal as reasonably possible, per stirpes. Any items not distributed in kind shall be sold and the net proceeds added to my residuary estate. Any remaining items shall be donated to charity or disposed of as my Executor deems appropriate.

ARTICLE IV
DISTRIBUTION OF RESIDUE OF ESTATE

I give the residue of my real and personal property, of every kind and wherever situated, that I own at my death or to which I may be entitled at my death to survives me to m HUSBAND, DIEGO ALEXANDER TRUHEART. If he does not survive me, I give my residuary estate to my CHILDREN, DAUGHTER, VALENTINA TATIANA TRUHEART, SON, ALEXANDER DIEGO TRUHEART, AND SON, DONOVAN FREDERICO TRUEHEART, in equal shares, per stirpes.

ARTICLE V
APPOINTMENT OF GUARDIAN OF MINOR CHILDREN

If at the time of my death, any of my children are under the age of eighteen (18) years and my spouse does not survive me, I hereby nominate and appoint my SISTER, PHOEBE LAFLEMMÉ as Guardian of the person and property of my minor child(ren). It is my desire that the Guardian shall have personal custody of my minor child(ren). I direct that the Guardian appointed shall serve without bond or sureties in this or any other jurisdiction.

ARTICLE VI APPOINTMENT OF EXECUTOR

I nominate and appoint my HUSBAND, DIEGO ALEXANDER TRUHEART, Executor of this, my Last Will and Testament. In the event he is unable or unwilling to serve, I nominate and appoint my SISTER, PHOEBE LAFLEMMÉ, as successor Executrix. I direct that my Executor and any successor be permitted to serve without bond and that if, notwithstanding this request, any bond is required by law, statute, or rule of Court, no sureties be required thereon so far as the law may permit.

ARTICLE VII FIDUCIARY POWERS

My Executor or his successor shall have full discretionary power to do whatever is necessary for the full administration of my estate. My Executor shall be entitled to reimbursement for all reasonable costs and expenses actually incurred and paid by my Executor on behalf of my estate under this Last Will and Testament. My Executor shall be entitled to compensation in a sum of five percent (5%) of the gross inventory value of my estate for services rendered as Executor under this Last Will and Testament.

ARTICLE VIII GENERAL PROVISION

Whenever it is provided herein that any person shall benefit if such person shall survive me, that person shall be deemed not to have survived me if he or she shall die within fourteen

(14) days after my death.

IN WITNESS WHEREOF, I, TATIANA TRUHEART, have hereunto set my hand and seal to this my Last Will and Testament, consisting of 5 (5) typewritten pages, each of which I have initialed or signed on this 25 day of March, A.D., 2023.
